MINUTES OF THE REGULAR MEETING OF THE BOARD OF TRUSTEES OF THE NORTH ORANGE COUNTY COMMUNITY COLLEGE DISTRICT

September 13, 2016

The Board of Trustees of the North Orange County Community College District met for its Regular Meeting on Tuesday, September 13, 2016, at 5:30 p.m. in the Anaheim Campus Board Room.

Board President Barbara Dunsheath called the meeting to order at 5:30 p.m. and led the Pledge of Allegiance to the Flag.

REPORTS

A. Chancellor Cheryl Marshall reported that the Cypress College Rededication Ceremony was extremely touching and a fitting tribute to honor the College's first 50 years, and she congratulated Fullerton College on their victory over Santa Ana College at the annual "Key to the County" football game. She also noted that she attended the California College Promise Conference in Oakland to discuss best practices and strategies for implementation of a promise program.

COMMENTS

A. **Greg Schulz**, Fullerton College President; **Bob Simpson**, Cypress College President; and **Valentina Purtell**, School of Continuing Education Interim Provost, reported on activities from their respective campuses.

During his report, Dr. Schulz introduced David Grossman, Fullerton College Dean of Physical Education, and Scott Giles, Fullerton College Athletic Director, who shared with the Board the key they retained for defeating Santa Ana College during the "Key to the County" football game.

As part of his report, Dr. Simpson announced his plans to retire as President of Cypress College at the end of the academic year.

- B. **Members of the Resource Table** Adam Gottdank, Bryan Seiling, Pete Snyder, Tina Johannsen, and Rod Lusch congratulated President Simpson on his retirement plans and thanked him for his leadership and friendship.
- C. Olivia Veloz reported on her attendance at the Cypress College professional development mixology event and noted the District Management Association will conduct a needs assessment survey for managers.
- D. **Adam Gottdank** reported on the SCE Opening Day event and the presentation by Dr. Tyrone Howard on the importance of empathy, and also provided an update on SCE's accreditation efforts. He also noted the passing of Kathryn Fay Baptista, a retired DSPS faculty member.
- E. **Bryan Seiling** thanked Chancellor Marshall for her attendance at the Cypress College rededication ceremony and mixology events, and stated that the Academic Senate's plans include setting up a distance education plan.

- F. **Pete Snyder** shared the strides that the Fullerton College Accreditation Steering Committee has made and expressed his gratitude to Jose Ramon Nuñez, Accreditation Liaison Officer, and Danielle Fouquette, Accreditation Faculty Co-Chair, for their leadership.
- G. **Tina Johannsen** noted that she enjoyed attending the SCE Opening Day event, and stated that the first United Faculty Executive Board meeting is scheduled for September 14.
- H. **Rod Lusch** thanked Interim Provost Purtell for her invitation to attend and address the SCE faculty and staff at their Opening Day. He also congratulated Cypress College for hosting an impressive rededication ceremony to kick-off the College's 50th anniversary activities.
- I. Kent Stevenson echoed the remarks about the SCE event, and reported on the trustee candidate interviews—by Adjunct Faculty United, United Faculty, and CSEA—to determine which candidates each union plans to endorse. He also shared Proposition 50 campaigning activities and invited everyone to attend the AdFac Back to School event on September 16.
- J. Student Trustee Tanya Washington reported on her attendance at various activities including the Cypress College welcome back event for new students and Club Rush.
- K. **Student Trustee Scott Begneski** reported on the second annual Fullerton College Quadchella event, and expressed his appreciation for the Cypress College remembrance event to mark the 15th anniversary of the September 11 attacks.
- L. **Trustee Stephen T. Blount** praised Cypress College for hosting such a meaningful Flagpole Rededication Ceremony that included a professional color guard and City of Cypress representatives.
- M. **Trustee M. Tony Ontiveros** remarked that President Simpson would certainly be missed upon his retirement, and also commended Scott Giles for his passion and dedication to Fullerton College athletics.
- N. **Trustee Molly McClanahan** echoed the remarks about the Cypress College rededication ceremony, especially the poem rendition by Liana Koeppel. She also referenced an article that appeared in *LiveWorkPlay*, the quarterly publication of the North Orange County Chamber of Commerce, that was written by Kai Stearns Moore and also profiled Chancellor Cheryl Marshall.
- O. **Trustee Leonard Lahtinen** noted that with his retirement, there will be a Board representative vacancy on the Fullerton College Foundation; Trustee Rodarte volunteered to serve as his replacement. He also urged the Colleges and SCE to open their doors to welcome displaced ITT Technical Institute students.
- P. **Trustee Barbara Dunsheath** reported on her attendance at SCE's Opening Day, the North Orange County Chamber of Commerce Legislative Reception, and

accreditation training. She also announced that Strategic Conversation #18 will take place on April 25, 2017 at the Anaheim Campus, and will address "Pathways."

MIINUTES: It was moved by Trustee Molly McClanahan and seconded by Trustee Jacqueline Rodarte to approve the Minutes of the Regular Meeting of August 23, 2016 as amended. Motion carried with Trustees Blount, Brown, Dunsheath, Lahtinen, McClanahan, Ontiveros, and Rodarte voting yes, including Student Trustees Begneski and Washington's advisory votes.

It was moved by Trustee Leonard Lahtinen and seconded by Trustee Jeffrey P. Brown to approve the Minutes of the Special Closed Session Meeting of August 27, 2016 as submitted. Motion carried with Trustees Blount, Brown, Dunsheath, Lahtinen, McClanahan, Ontiveros, and Rodarte voting yes, including Student Trustees Begneski and Washington's advisory votes.

PUBLIC HEARING: At 6:25 p.m., Board President Barbara Dunsheath opened the public hearing on the Proposed 2016-17 District Budget. Kashu Vyas, Interim District Director of Fiscal Affairs, presented the District's 2016-17 Proposed Budget which included the following highlights:

- Budget Book: A review of the sections contained within the budget book, including their purpose and relevance, and the District's overall budget position. An overview of general fund, and non-general District funds, and CCFS-311Q report to the State.
- Community College Budgets: A \$311 million increase in Proposition 98 funding; augmentations for completion rate and access programs; the sunset of Proposition 30 Education Protection Account (EPA) funding; future PERS/STRS rate increases; and the lack of Cost of Living Adjustment (COLA) funding.
- **District Strategic Directions**: A matrix identifying the \$31.6 million which have been allocated District-wide based on the Strategic Directions, as well as additional dollars to non-categorical funds related to directions 1, 2, and 3.
- Fiscal Analysis: The District's fiscal analysis includes the following:

On-going Unrestricted Revenue Summary: \$ 190,135,793 On-going Unrestricted Expenditures Summary: \$ 190,062,117 Ongoing Surplus: \$ 73,676

It was also noted that, with the exception of part-time faculty, all other employee classification groups are back to pre-recession numbers.

• **Ending Balances**: The adjusted ending balance for the District was \$49.8 million. However, Ms. Vyas outlined that the ending balance is comprised of the following:

- Outstanding Issues: Outstanding issues facing the District's budget include:
 - Bringing salaries and benefits in alignment with comparable districts
 - o Proposition 30 Sunsets: sales tax in 2016 and income tax in 2018
 - o Retiree Benefits Annual Required Contribution (ARC)
 - STRS/PERS planned rate increases
 - o 50% Law
 - Sustainable growth
 - System-wide shortfall
 - Pension reform and healthcare legislation

Subsequent to her presentation, Ms. Vyas provided clarification on questions related to: the variation in personnel cost percentages; progress on prerecession figures for faculty, but not classified employees; personnel costs in relation to the overall budget; the 5% Board Policy contingency; the addition of students to the District Enrollment Management Committee; the District's inflated Full-time Faculty Obligation number; the \$4 million correction to the 311Q; plans to reapply for the Title V Hispanic-Serving Institutions (HSI) Program grant; and pursuit of additional veterans' grants.

Finance staff were commended for tying dollars to the District's Strategic Directions. It was also noted that while there is always pressure to increase FTES production, that should not overshadow the District's primary goals of student success, retention, and completion.

At 7:30 p.m., it was moved by Trustee Jeffrey P. Brown and seconded by Trustee Jacqueline Rodarte to close the public hearing. Motion carried with Trustees Blount, Brown, Dunsheath, Lahtinen, McClanahan, Ontiveros, and Rodarte voting yes, including Student Trustees Begneski and Washington's advisory votes.

Item 3.a: Upon conclusion of the public hearing, it was moved by Trustee Jeffrey P. Brown and seconded by Trustee Jacqueline Rodarte that the Board adopt the 2016-2017

Proposed Budget with a General Fund Budget totaling \$306,038,511 and associated funds as summarized in the Proposed Budget Book, and approve the Gann Appropriation Limit, which is \$333,534,020. In addition, the Board adopted a resolution to certify the approval of entering into agreements and any amendments with the California Department of Education and authorized the Vice Chancellor, Finance & Facilities, or the District Director, Fiscal Affairs, to sign contract documents for fiscal year 2016-2017. Motion carried with Trustees Blount, Brown, Dunsheath, Lahtinen, McClanahan, Ontiveros, and Rodarte voting yes, including Student Trustees Begneski and Washington's advisory votes.

Resolution adopted. (See Supplemental Minutes #1176 for a copy of the resolution.)

FINANCE & FACILITES

Item 4.a: It was moved by Trustee Jeffrey P. Brown and seconded by Trustee Jacqueline Rodarte to authorize the design and build of a new Science, Engineering, and Mathematics Building at Cypress College without Leadership in Energy and Environmental Design (LEED) commissioning. Rather, the building shall be designed and constructed to meet the California Green Building Standards Code, Title 24, part 11. As part of the discussion, Susan Rittel, Cypress College Campus Capital Program Manager; and Karen Cant, Cypress College Vice President of Administrative Services, conducted a short presentation which included an introduction to LEED, the costs and concerns associated with it, and their recommendation to pursue California Green Building Standards Code as the equivalent to LEED certification. Motion carried with Trustees Blount, Brown, Dunsheath, Lahtinen, McClanahan, Ontiveros, and Rodarte voting yes, including Student Trustees Begneski and Washington's advisory votes.

Item 4.b: By block vote, authorization was granted to enter into a travel arrangement with AIFS for the Cypress College and Fullerton College 2017 Summer Study Abroad Program in London, England. The basic program fee of \$4,940, which is to be paid by each student, includes housing, round trip flight, an orientation, support staff, travel excursions, a travel pass in London, and some meals.

Further authorization was granted for the Vice Chancellor, Finance & Facilities, to execute the agreement on behalf of the District. A signed copy of the travel contractor agreement will be on file in the District's Business Office.

Item 4.c: By block vote, authorization was granted for Fullerton College to rent the Campus Theatre to Pathways of Hope on February 9, 2017, and allow them to sell alcoholic beverages to attendees.

Further authorization was granted for the Fullerton College President to execute the agreement.

Item 4.d: It was moved by Trustee Leonard Lahtinen and seconded by Trustee Molly McClanahan to award RFQ #2016-07, Network Assessment, to WTC Consulting, Inc. in the amount of \$130,000. Subsequent to the Board expressing their gratitude for the explanation related to the role that the Gartner Group played in the selection process, the **motion carried with Trustees Blount, Brown, Dunsheath, Lahtinen, McClanahan,**

Ontiveros, and Rodarte voting yes, including Student Trustees Begneski and Washington's advisory votes.

Authorization is further requested for the Vice Chancellor, Finance and Facilities, or the District Director, Purchasing, to execute the agreement on behalf of the District.
