BACKGROUND: The California State Legislature provided \$70 million in the 2014-15 Budget Act to establish the Student Equity Program “in order to ensure equal educational opportunities and to promote student success for all students, regardless of race, gender, age, disability, or economic circumstances”. While a requirement has been in place since 1996 that colleges adopt Student Equity Plans, this is the first time that dedicated state resources have been provided to support efforts to achieve the goals reflected in those plans.

On September 2, 2014, the District was notified that it had been allocated \$1,827,580 in Student Equity Program Funds for 2014-15. The Funding Formula Factors were as follows:

The proceeds from the 2002 bond issuances were initially placed into two separate funds at OCDE. The General Obligation Bond Series 2002B Sub-Fund (Fund 2122) was primarily used to house funds, with transfers being made to the related General Obligation Bond Series 2002A Sub-Fund (Fund 2121) as project expenses were incurred. The separation of the bond funds was an OCDE designation and did not impact the actual projects completed. As completion of the projects funded by these bonds is near, all remaining funds are in Fund 2121 and no funds remain in Fund 2122. Therefore, staff recommends closing Fund 2122 with OCDE. This agenda item is submitted by Rodrigo Garcia, District Director, Fiscal Affairs.

Additionally, in November 2009, the Board authorized the establishment of Bursar Sub-Funds with OCDE to allow the campuses to utilize the Orange County Treasury investment vehicle, with separate Sub-Funds being established for each campus only for the purpose of investing cash, should the campuses choose to do so. As a result, the School of Continuing Education (SCE) was provided with the SCE Bursar Sub-Fund (Fund 2028) with OCDE. However, SCE has not chosen to use their Sub-Fund for the purpose of investing cash and does not foresee an immediate need to so utilize their Sub-Fund. Therefore, staff recommends closing Fund 2028 with OCDE. BACKGROUND: Assembly Bill 1908 specifies procedures for appointing a Citizens' Oversight Committee which is responsible for informing the public concerning the expenditure of bond proceeds and actively reviewing and reporting on the proper expenditure of taxpayers' money for school construction.

As of August 2014, two members of the District's Citizens' Oversight Committee representing the Student Organization category have either resigned or have completed service on the committee. The individuals identified below have expressed interest in serving on the committee.
