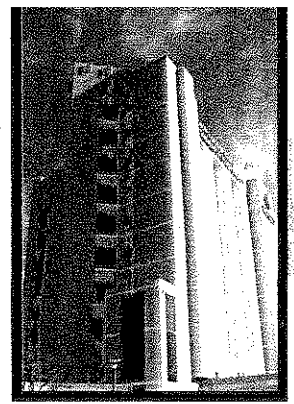

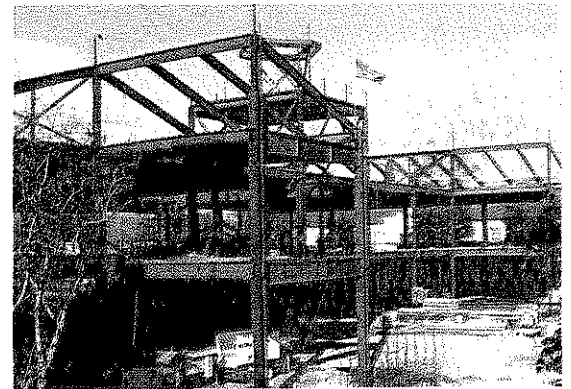
REPORT TO THE COMMUNITY *FACILITIES BOND PROJECTS* 4/04

Measure X Benefits Local Colleges

Measure X, approved by voters in March, 2002, provides the North Orange County Community College District, which includes Fullerton College, Cypress College, the Anaheim Campus, and the School of Continuing Education, with many important facility improvements. The bond measure provides \$239 million for the improvement and expansion of college and continuing education facilities to ensure the best possible educational opportunities for the District's residents and businesses. The community's investment in education has already made many improvements possible, with many more slated over the next four years. As you will read here, several NOCCCD educational facilities are being remodeled, constructed, or relocated to ensure accessibility, safety and high quality educational standards.

Fullerton College's New LLRC is Beginning to Bloom

Construction of Fullerton College's new 66,000 square foot Library and Learning Resources Center (LLRC), located at the north end of the campus quad, is in full swing. As part of the LLRC, the William T. Boyce Library will feature a computer commons and wired reading tables and carrels throughout. New construction for the learning resources portion enables the centralization of



services such as the Math Lab, Skills Lab, Reading Lab, Tutoring Center, Writing Center, Staff Development Lab, and Adaptive Services Center. As construction continues through December of 2004, students and staff look forward to the Center's grand opening in February, 2005.

Spring Marks the Start of Two Fullerton Projects

At the corner of Grove and Lemon Streets in Parking Lot C-West, at Fullerton College, a permanent Campus Safety Building will be constructed to house the campus safety staff and serve as an information entry point for the campus. The 2,000 square foot structure will get under way in April, 2004, with an expected completion date of September, 2005.

Construction of a new structure to house the College's Maintenance and Operations shops and storage and the Academic Computing Technologies Programs begins in Spring, 2004 as well. To date, the Maintenance/Operations and Academic Computing functions have occupied temporary buildings, but now they each look forward to a new, permanent home. Parking Lot 3 is the construction site for the new 17,300 square foot building, scheduled for completion by the end of the year.

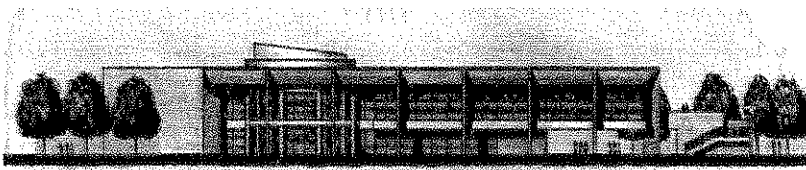
Looking Ahead at Fullerton College

During the Fall Semester of 2004 several Fullerton College projects will begin, most of which will improve facilities that house student programs. The remodeling of the old District Education Center, or DEC, will accommodate the Cosmetology and Day Spa Programs. Phase one of the Physical Education Complex renovation will also begin next fall. New locker rooms, activity spaces and an aquatic facility will be constructed. Some modifications to the athletic fields will also be made. Last, Maintenance and Operations will gain another facility, off Berkeley Street, to house shops and storage.

Construction of the new Lemon Street Parking Structure will start in July, 2004, following the demolition of the boiler house, Administrative Services buildings, Parking Lots 1 and 2 and the Cosmetology patrons' lot. With these programs and facilities being relocated, remodeled or reconstructed, construction space will be ample for the new parking lot that will offer much-needed relief to students next year.

Centralizing Learning Resources at Cypress College

At Cypress College, a new Library and Learning Resources Center (LLRC) is under construction. Since it is being built on existing open space, the LLRC was the logical first step in a string of Cypress College construction projects. The new Center will bring together the College's Library, open computer labs, Math Lab, Learning and Writing Center and Teaching and Learning Center. Scheduled to be complete in the late summer/early fall of 2005, the new LLRC unites under one roof many learning resources that have been spread across the campus.

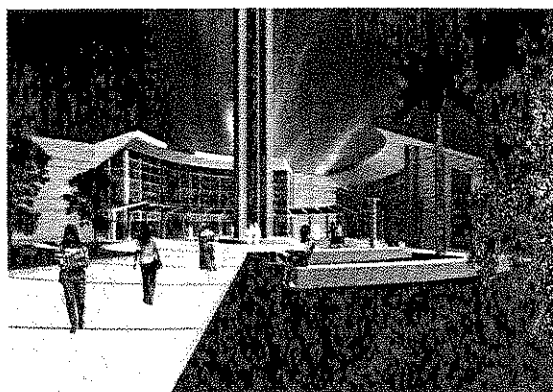


Cost and Energy Savings Drive Cypress' New Cogeneration Plant

A new Cogeneration Plant will provide the College with electricity, making it necessary to purchase electricity only when the College's own supply is exhausted. The plant will be capable of lighting all campus buildings in the case of an electricity blackout. As an added benefit, the heat generated as a byproduct of the cogeneration unit will heat the campus pool. The plant offers the College significant energy and cost savings.

Welcome to Cypress College! New Entrance Befits the Campus' New Look

An open, welcoming feel will grace the main entrance to Cypress College, from Valley View Street. To make the campus more accessible and friendly, there will be new signs directing drivers to parking lots, especially to visitor parking. The front of the campus will be named, "Celebration Plaza" and will accommodate campus activities. Celebration Plaza will offer shade trees, lighting for nighttime events, and an open space for large gatherings. Attractive landscaping and "hardscaping" will lend to the entrance's new look. Given the proximity of the main campus entrance to the College's new Student Center, which is scheduled to break ground in the Summer, 2004, the entrance improvements will occur in sync with the Center's progress.

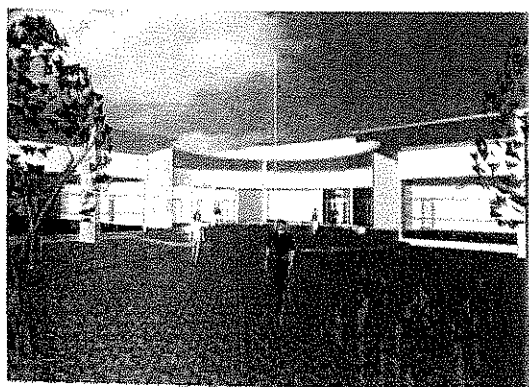


Truly the "Center" of Campus

A brand new Cypress College Student Center to house Admissions and Records, Disabled Students Program and Services, the Bookstore, and many other services, will be built in the center of campus, next to the College's Campanile. The Center, scheduled for completion in 2006, will stand adjacent to the Student Activities and Administration Buildings (formerly the Library/Administration Building), comprising a complex of service-oriented functions.

Remodel Awaits Piazza North, then Piazza South

Cypress College's extensive Piazza, a second floor walkway connecting most of the buildings on campus, will be upgraded in two phases. While the north side is being remodeled, the south side will remain intact and vice versa. At this time, the Piazza remains open, although railings have been replaced by temporary chain link fencing in preparation for the remodel. While part of the Piazza will be removed to make way for the new Student Center, this critical connection of campus buildings will be vastly improved for student access and safety.



New Building Slated for School of Continuing Education at Cypress College

The continuing education program located on the Cypress College campus will move out of portable buildings and into a permanent structure when its new classroom/office building is completed in March 2006. Groundbreaking on the project is scheduled for July 2005.

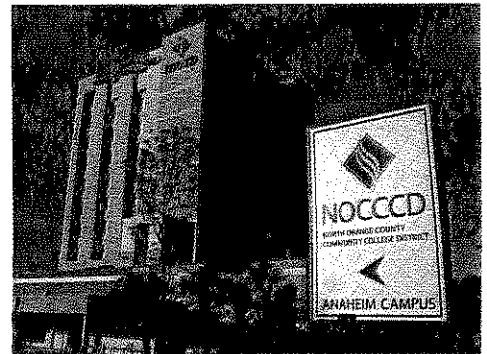


Citizen's Oversight Committee

The NOCCCD's Citizen's Oversight Committee meets four times a year to review the District's compliance with the voter-approved plans for use of Measure X funds. In addition, the Committee is responsible for overseeing an annual fiscal audit, which was recently completed by the firm of Vicente, Lloyd and Stutzman. In January, 2004, the firm reported that the NOCCCD's use of bond funds was well-aligned with voter-approved projects.

The Citizen's Oversight Committee is comprised of nine members representing different segments of the community and includes Darrell Essex-Committee Chair, Don Baldwin, Ray Estrella, George Tsuda, Chris Lowe, Mary Bouas, Rowland Hill, and student representatives Tatyana Alvarez of Cypress College, and Sonya Servin of Fullerton College. The Committee's members serve two-year terms and receive no compensation. Reporting to the District's Board of Trustees, the Citizen's Oversight Committee is regulated by the Ralph M. Brown Act of 1953, which among other requirements, calls for public meetings.

The next meeting of the Citizen's Oversight Committee is scheduled for July 14, 2004 at 7:00 p.m. in the Board Conference Room, first floor of the Anaheim Campus.
