The following additional information was provided regarding the August 27 Board meeting agenda:

Item 3.a, Purchase Order Listing:

1. P0133193: Please contextualize this purchase. **This is a blanket order to pay Temp Power Systems for the monthly rental fees of temporary power poles that provide power to the Fullerton College relocatable classrooms/portables numbered 1955-1960 (located south of the tennis courts) for the period beginning July 1, 2019 – June 30, 2020 at \$250 per month, for a total of \$3,000 per year.**
2. P0133835: Please contextualize this purchase. **This purchase of \$28,490 is for 50,000 Buen Cypress granola bars for Cypress College's campus-wide grab and go campaign.**
3. P0133851: Please contextualize this purchase. **Each semester Fullerton College makes arrangements for experts to adjudicate their students in the stage combat class offered by their Theatre Arts department. They use adjudicators who are approved by the Society of American Fight Directors. If the students pass the exam, they are certified by the Society of American Fight Directors. In order to issue authorized certificates to students, Fullerton College must pay a fee of \$100 to the Society of American Fight Directors to grant permission to the College to certify the students.**

Item 3.b, Quarterly Investment Report and Irrevocable Retiree Benefits Trust Report:

1. Page 3: Assuming that Capital Outlay Fund is separate from Bond Funds? Correct? **Correct, the Capital Outlay Fund is separate and consists of dollars accumulated for capital projects. Accumulated dollars are from Redevelopment Fund, and monies set aside for projects like Fullerton College M&O Building, Network Refresh project, and scheduled maintenance.**
2. Pages 6 and 7: Since all of these are CDs, and SchoolsFirst tend to provide better interest rates, has Cypress College considered moving some of their accounts to SchoolsFirst, or are we tied to 3-year contracts? **CD decisions are made when dollars are available to invest. With the longer commitment period, the yields are higher. Investment returns have been improving, but to close a CD before the maturity period requires a withdrawal penalty. Campus staff will evaluate the cost benefit of making such a move.**
3. Page 8: What are portfolio fees based on...e.g. percent of portfolio value at a given time? **Portfolio fees are based on the End of Month market value using the agreed upon fee schedules. The portfolio fee consists of the payments to Morgan Stanley, Keenan & Associates, and Benefits Trust Company.**

Item 3.c, 2019-20 Mandate Block Grant Participation

1. Can you explain what strings are attached to receiving these funds? **There are no strings attached. The District considers them unrestricted General Fund ongoing revenue.**
2. Is it just funds that are to pay directly for costs the District incurs as a result of new regulations mandated by new laws passed by the legislature? **No, they are considered unrestricted General Fund ongoing revenue. The funds are received for FTES, not specific programs or regulations.**

Item 3.e, Cost Information the Sale of 2014 General Obligation Bonds, Series B:

1. How many series are we going to have in total? **We expect to have four series.**

2. What feedback did we get from our Bond Oversight Committee? **It is on the agenda for the September 4 Citizens' Oversight Committee meeting.**

Item 3.g, Sherbeck Field Improvements EIR Contract Amendment No.2 Request:

1. With the additional work that needs to be completed, when do we anticipate the Board finalizing the vote on Sherbeck Field? **The schedule reflects a public hearing and a vote from the Board at the first meeting in October.**
2. What is the estimated time to receive the additional analysis? **The additional analysis will be incorporated into the Final EIR prior to the public hearing in October.**
3. What is the estimated time for the public hearing on Sherbeck Field Improvements? **At this time, the public hearing is projected to be held during the first Board meeting in October.**

Item 3.j, Out-of-Country Travel:

1. Are we still not allowed to approve travel to Texas due to the mandate from our state because of "human rights?" If so, human rights in Myanmar (Burma) under its military regime have long been regarded as among the worst in the world ("Human Rights in Myanmar" has its own Wikipedia page and that's line 1). **That is correct. California community colleges are still not allowed to approve travel to Texas due to a ban mandated by the State of California and affirmed by the State Chancellor's Office.**
2. Is the District paying for this (out of district funds or from an outside grant) and what is the expected return on this investment? **The District is essentially paying for this recruitment travel through funds derived from Fullerton College generated non-resident fees paid by existing Fullerton College international students. The expected return on investment is difficult to predict, but at the very least we do know that international students will pay non-resident fees of \$331 per unit versus \$46 per unit paid by resident students and are required to take at least 12 units per semester to maintain their student visa status. One student matriculating to Fullerton College would produce at least \$7,944 in non-resident fees per year.**
3. Why or how would international recruitment yield better returns than local or domestic recruitment (or recruiting international students already living here when they are enrolled in K-12)? **The Fullerton College International Student Center already has plans in place to recruit international students studying locally in Southern California, however, there are only so many students studying at local area high schools. In order to grow the international student population at Fullerton College we need to look to overseas recruitment options in order to engage students who are preparing to come to the United States to study at the college and university level. Additionally, many countries (such as Japan) have country initiatives or government funded scholarships to encourage their students to study abroad for their higher education.**
4. Can you let us know who is funding these trips and why it needs to be approved by the Board if we aren't? **The recruitment trip is being funded by the International Students Program budget, funded by non-resident fees. The matter is coming to the Board as required by Board Policy 7400 Travel and Conference Attendance, Section 3.0, "All Travel outside the United States must be approved in advance by the Board."**

5. Why is our district recruiting community college students from other countries and how many future FTES is this likely to yield? **Fullerton College prioritizes diversity and the promotion of educational opportunities and has found that international students bring a richer tapestry of culture and viewpoints to the campus. The Fullerton College International Student Center currently has approximately 300 international students enrolled and would like to see this number grow to 450-500 students over the next 3-5 years. The number of international students has dropped over the past few years. An additional 200 students would produce an additional \$1.5 million annually in non-resident tuition.**
6. I would like to see our cost benefit ratios for recruiting costs for domestic students (or international students already in country) vs international students. **Cost benefit ratios for international recruitment are not currently available because international recruitment has never been done at Fullerton College, either domestically or internationally. As a baseline, typically one matriculated non-resident international student will pay a minimum of \$7,944 per year. If one recruitment trip yields at least one student, then the cost of the trip will be covered. Any additional students matriculated will only add further to the benefit earned.**
7. If international student recruitment were to become a focus, shouldn't online methods of recruiting be expected to yield the most results for the money? **Online recruitment does play a role in any recruitment strategy and will continue to be utilized. However, there is no substitute for actual in-person recruitment and the effects it has in creating trust, goodwill, and relationship building. Face-to-face recruitment is still a vital aspect of successful recruitment, especially in countries where relationships are built on trust and built up over time.**
8. Do these representatives speak Japanese and Burmese with enough fluency to communicate with prospective students in these countries (assume they do but want clarification). **Alexander Brown, who will be the principal recruiter, has knowledge of Burmese due to his family being from Myanmar. Fluency is not required, as all or most students who are interested in studying abroad have good English skills and must already have a basic fluency in English to be admitted to Fullerton College.**
9. How were these two countries selected and what makes them the best international locations to recruit students at this time?
Japan and Myanmar were selected because Alexander Brown, principal recruiter on this trip, has recruited extensively in those countries while working for California State University, Northridge. Based on his familiarity and established connections in both countries, the Fullerton College International Student Center made the decision to focus their initial recruitment efforts there. In addition to Mr. Brown's connections and established relationships, the Japanese government has increased funding for further internationalization of their students, which has given a boost to the number of Japanese desiring to study abroad. Myanmar has also recently opened its borders and is estimated to become the next "big market" for international students studying abroad – similar to China and Vietnam over the past decade. Myanmar citizens have had an affinity and desire to study in the United States for decades, but it was difficult to obtain a visa. Many opted to study in the United Kingdom. Now the country has become more open and recently the United States has relaxed some of its restrictions on travel from Myanmar. We believe there is a large opportunity for Fullerton College to establish itself in the market, early, before other schools begin to visit.

10. Please explain how the human rights in the American state of Texas are worse than Myanmar (Burma)? **By requesting approval for this out-of-country travel request, staff are not intending to convey that human rights are worse in one area versus the other. Staff are merely honoring the pre-approval required by BP 7400.**

Item 3.k, Contract Extension with DLR Group for Fullerton College Architectural Consultant Service Agreement:

1. What projects are being handled by DLR and what stages are they in? **DLR is currently providing architectural services support for the Sherbeck Field EIR, which is nearing completion.**
2. What can you share about need for a new selection process for architectural consultants? **Existing selection processes for architectural consultants are sufficient. DLR will reach the end of their 5-year maximum in 2020. We expect the selection process for campus architectural consultants to commence FY 2020-2021.**

Item 3.l, Orange County Hispanic Chamber of Commerce Institutional Membership:

1. Paragraph 2 talks about opportunities for networking, legislative advocacy, access to capital, education and training programs. Does this cover potential internships for students? **Yes, and we have had conversations with the representative about our goal of increasing internships.**

Item 4.a, CCAP Dual Enrollment Agreement with Garden Grove Unified:

1. Why did Garden Grove Unified reach out to us and not Coast Community College District? Are they okay with a three-year agreement? **Garden Grove Unified is in three districts: Rancho Santiago CCD, Coast CCD, and NOCCCD. The dual enrollment agreements will cover the high schools in our service area.**
2. The third goal to improve high school graduation rates is laudable. Who does the linear studies to provide the data to measure this goal and its measurable objectives? **Garden Grove will do the analytics on their own populations, but we will be data sharing so we also understand the impact of dual enrollment on these students.**

Item 5.c, Professional Experts:

1. Page 5.c.4: What does "PAL" stand for? **PAL stands for Peer Assistance Leader.**
2. Page 5.c.5: What does "SWP" stand for? **SWP stands for Strong Workforce Program.**

Item 6.b, Revised AP 6700, Civic Center and Other Facilities Use: Attached are replacement pages for this item. The only change made, subsequent to the discussion at yesterday's District Consultation Council meeting, was to Section 3.4 on page 6.b.4, in order to change "he/she is" to "they are" and is noted in red.

1. What current, outside groups does Fullerton and Cypress College allow to use their outdoor facilities? What are the general time frames these organizations use the outdoor facilities? **At Cypress College, we occasionally open the Theatre and Art Gallery to guests lecturers or speakers, as well as utilize the outdoor space in front of the theatre or gallery for an event. There are transfer fairs in the front quad and breezeway areas for outside vendors, activities for students, and guests who might come on campus for Black History Month, Hispanic Heritage, DSS, and LGBTQ awareness. Cypress College has future plans to allow**

the new Veterans Outdoor Complex to be used by outside veteran groups, and this past 4th of July, the entire campus was used for the City of Cypress Fireworks show.

Fullerton College typically rents outdoor athletic facilities to non-profit and for-profit sports organizations, private high schools, and other higher education institutions. Occasionally law enforcement groups, such as the Buena Park Police Department, and local public high schools use Fullerton College facilities. Public high schools only use Fullerton College facilities if they have an urgent need, such as emergency repairs at their campus. The various fields and courts are typically used at times between 6:00 a.m. and 6:00 p.m. The Fullerton College Aquatic Center has lights, and some clients rent the pool until 9:00 p.m. for practices on weeknights.

2. What are the times our students use outdoor facilities at both campuses? **At Cypress College, usually during the lunch hour (11:00 a.m. to 2:00 p.m.) for Associated Students and club activities. At Fullerton College, the hours vary each day but some classes begin as early as 6:00 a.m. and can run as late as 11:00 p.m. in the aquatic center/pool.**
3. Throughout the week, what do you anticipate to be the usage of outdoor facilities at both campuses? **For Cypress College, it varies from week to week depending on time of the semester, programs that are being promoted, and activities for students. The campus uses their outdoor spaces, both internally and externally, almost every week. The attached room reports are indicative of the anticipated student usage for the fall and spring semesters at Fullerton College.**
4. What do the Cities of Cypress and Fullerton consider hours where noise complaints are follow up with/ enforced by law enforcement? **At Cypress College if an event goes after 10:00 p.m. a courtesy notice is sent to all neighbors. Fullerton College follows city recommendations of limiting high noise-producing activities between the hours of 7:00 a.m. and 8:00 p.m. City Municipal Code Noise Standards Exemptions are for school bands, school athletic events school entertainment events, and for public locations for activities conducted in public parks, public playgrounds and public or private school grounds.**

1.0 **General Provisions**

1.1 District facilities are available for community use when such use does not conflict with District programs and operations. Facility use shall be limited to places and times identified by authorized individuals according to Section 1.1 of Administrative Procedure 6150, Designation of Authorized Signatures. Except as provided in ~~these regulations~~ this procedure, or as authorized by law, no organizations shall be denied the use of District facilities because of the content of speech to be undertaken during the use. The authorized individuals are responsible for the coordination and implementation of these procedures and shall determine all applicable fees to be charged.

1.2 Outside the designated public forum areas (as defined in BP/AP 5550, Speech: Time, Place, and Manner), the following shall apply: All user groups shall be required to provide the District with a hold harmless and indemnification agreement acknowledging that they will be financially responsible for any losses, damages or injuries incurred by any person as a result of their use of the facilities. All user groups shall also be required to provide a certificate of insurance and separate endorsement with limits acceptable to the District and/or proof of financial responsibility acceptable to the District.

2.0 **Civic Centers**

2.1 Eligible persons or groups may use District buildings or grounds for public, literary, scientific, recreational, or educational meetings, or for discussion of matters of general or public interest, subject to these rule and regulations.

2.2 The District may charge the groups identified in Education Code Section 82542(a) an amount not to exceed the following:

2.2.1 The cost of opening and closing the facilities, if no District employees would otherwise be available to perform that function as a part of their normal duties.

2.2.2 The cost of necessary college employees' presence during the organization's use of the facilities if it is determined that the supervision is needed, and if those employee(s) would not otherwise be present as part of their normal duties.

2.2.3 The cost of ~~janitorial~~ custodial services and security services, if those services are deemed necessary and would not have otherwise been performed as part of their regular duties.

AP 6700 Civic Center and Other Facilities Use

- 2.2.4 The cost of utilities directly attributable to the organization's use of the facilities.
- 2.2.5 Additionally, except for classroom-based programs that operate after school hours and organizations retained by the college or District to provide instruction or instructional activities to students during school hours, direct costs shall also include the costs for maintenance, repair, restoration, and refurbishment of college facilities and grounds used by the group.
- 2.3 Except as provided herein, for other civic center events that do not qualify in Section 2.2, and where no charge or solicitation is made to participants, minimum fees shall apply in addition to necessary direct costs. Direct costs shall include supplies, equipment, utilities, janitorial ~~custodial~~ **custodial** services, services of any other District employees, and salaries paid to District employees necessitated by the organization's use of District facilities.
- 2.4 Other non-college sponsored groups including for-profit companies shall be charged fair rental value at double the minimum charge for the use of District facilities including:
- 2.4.1 Any church or religious organization for the conduct of religious services for temporary periods where the church or organization has no suitable meeting place for the conduct of such services.
- 2.4.2 Entertainments or meetings where admission fees are charged or contributions are solicited and the net receipts of the fees or contributions are not expended for the welfare of the students of the District or for charitable purposes.
- 2.5 The District shall maintain a fee schedule adopted by the Board **of Trustees** that includes the hourly fee for each specific school facility and grounds.
- 2.6 The American Red Cross or other public agencies may use the District facilities, grounds, and equipment for mass care and welfare shelters during disasters or other emergencies affecting the public health and welfare, and the District will cooperate with these agencies in furnishing and maintaining services mutually deemed necessary to meet the needs of the community.
- 3.0 **Rules for Facilities Use**
- 3.1 Requests for use of District facilities must be made at least fourteen (14) business days in advance of the first date of use being requested. Requests shall be in the **application** format required by the District. Permission to use facilities shall be granted by those authorized individuals according to Section 1.1 of Administrative Procedure 6150, Designation of Authorized Signatures **and includes the following**

3.1.1 Chancellor

3.1.2 Vice Chancellors

3.1.3 College Presidents

3.1.4 Provost

3.1.5 Vice President, Administrative Services

3.1.6 Director, Fiscal Affairs

3.1.7 Director, Administrative Services

3.1.8 Manager, Campus Accounting

3.2 Permission to use District facilities shall not be granted for a period to exceed one fiscal year. No person or organization may be granted a monopoly on any facility.

3.3 All charges for the use of District facilities are payable prior to usage.

3.4 Any persons applying for use of District property on behalf of any groups shall be a member of the groups and, unless ~~they he/ or she is~~ **are** an officer of the group, must present written authorization to represent the group. Each person signing an application shall, as a condition of use, agree to be held financially responsible in the case of loss or damage to District property.

3.5 The District may require security personnel as a condition of use whenever it is deemed to be in the District's best interest.

3.6 No person applying for the use of District property shall be issued a key to District facilities.

3.7 Future facility requests may be denied on grounds including, but not limited to, abuse or misuse of District property, failure to follow any of the rules of use as identified in the Application and Agreement of Use of Facilities, and failure to pay promptly for any damage to District property.

3.8 No alcoholic beverages, intoxicants, controlled substances, or tobacco in any forms shall be brought onto the property of the District. Persons under the influence of alcohol, intoxicants, or controlled substances shall be denied participation in any activity.

3.8.1 Allowable exceptions are limited to those outlined in Sections 3.3, 3.4, and 3.5 of Administrative Procedure 3560, Alcoholic Beverages.

3.9 No structures, electrical modifications, or mechanical apparatus may be erected or installed on District property without specific written approval by authorized individuals according to Section 1.1 of Administrative Procedure 6150, Designation of Authorized Signatures.

AP 6700 Civic Center and Other Facilities Use

- 3.10 All decorative materials, including but not limited to draperies, hangings, curtains, and drops shall be made or treated with flame-retardant processes approved by the State Fire Marshall.
- 3.11 Overnight camping on District facilities, including in the designated public forum areas, is prohibited. No person or organization may use any District facility for living accommodation purposes such as sleeping activities, or making preparations to sleep (including the laying down of bedding for the purpose of sleeping), or storing personal belongings, or making any fire, or using any tents or other structure for sleeping, or doing any digging or earth breaking, or carrying on cooking activities.

4.0 Minimum Fees

- 4.1 Facilities use fees vary from site to site and from room to room. Each site establishes and maintains a fee schedule, which includes weekday rates and weekend rates.
- 4.2 Fees are charged with a minimum use of four hours and per hour afterward.
- 4.3 If multiple locations are being rented simultaneously, the most expensive location will be rented at the regular fee and the additional location(s) may be rented at fifty percent (50%) of the regular fee.
- 4.4 Fees cover operating costs including utilities except for the telephone, set-up according to approved usage authorization, normal clean-up, and attendant on duty.
- 4.5 Additional operating costs may be assessed at an hourly or applicable timed rate for incurred usage charges, required personnel, and special equipment.
- 4.6 Rehearsal usage will be charged at one-half the regular fee in instances where there is no technical equipment or support needed.
- 4.7 When applicable, booking deposits shall be equal to twenty-five percent (25%) of the four (4) hours minimum rate. Booking fees are applicable toward cumulative rental fees incurred. If a cancellation of reserved facilities occurs within seventy-two 72 hours of the scheduled event date, said booking fees will be retained to cover administrative expenses.
- 4.8 A two-hour minimum charge may be applied toward any incurred charges for on-site support IT or AV technical staff.
- 4.9 Lease Tenants of the Anaheim Campus shall be charged rental fees based on fifty percent (50%) of the Anaheim Campus standard rental schedule.

5.0 Sherbeck Field Usage

- 5.1 No Fullerton College football games shall be played on Friday evening.**

AP 6700 Civic Center and Other Facilities Use

5.2 No high school football games shall be played at Sherbeck Field.

5.2.1 Exceptions may be made for temporary use during extenuating circumstances.

5.3 Field lighting shall not be used for any outside groups at any time on Saturday and Sunday.

5.4 No field rentals for the purpose of musical performances or concerts by outside groups or individuals will be permitted.

5.5 The public address system is only for use by Fullerton College. Outside groups using the field are prohibited from using any public address or sound amplification systems.

See Board Policy 6700, Civic Center and Other Facilities Use; Administrative Procedure 6150, Designation of Authorized Signatures; and Administrative Procedure 3560, Alcoholic Beverages.
